

Our vision is that Queensland children, young people and families in all their diversity are thriving with access to support when and where it's needed.






PeakCare's New Vision

Policy, Advocacy & Research

In 2023-24, PeakCare focused on transforming the best available knowledge, research, and insights into innovative practices, policies, and reforms. This ensured the child and family sector was well-equipped to improve outcomes and foster greater wellbeing for all children, young people, and families in Queensland.

Government Engagement

Throughout 2023-24, PeakCare actively participated in numerous state government forums and strategic meetings aimed at improving system capacity and capability. These engagements included:

Participated in **12** key forums including the Queensland Child Death Review Board and the Residential Care Review Project Executive Group, where PeakCare provided critical insights and recommendations.

Representation in all Social Services Industry Reference Group meetings, focusing on exploring the true cost of service delivery and improving sector sustainability.

Regular attendance at the Youth Justice Strategy Reference Group meetings, contributing to discussions on youth justice reforms and the intersection between child safety and youth justice systems.



Individual meetings and briefings with Ministers, Directors-General, and other senior government officials.

Support for Aboriginal and Torres Strait Islander Children

•

PeakCare continued to support the transition of child protection services to Aboriginal and Torres Strait Islander community-controlled organisations. Our engagement with QATSICPP and participation in the Queensland Family Matters Leadership Group has been central to these efforts. We have actively promoted culturally safe practices and advocated for the rights of First Nations children and families.

Supporting cultural needs: Working with culturally and linguistically diverse children in out-of-home care

In March 2024, PeakCare co-hosted an online focus group in partnership with Western Sydney University, Macquarie University and the University of Sydney about upholding the right to cultural connection for children from culturally and linguistically diverse (CALD) backgrounds in care. The focus group contributed to a research project to support the development of an exemplary model of care for children from culturally and linguistically diverse (CALD) backgrounds.

Promotion of Child Safety Legislation

PeakCare has been actively involved in promoting and supporting the implementation of the *Human Rights Act 2019* within the child protection sector. We have disseminated educational resources and engaged with sector members to ensure compliance and enhance understanding of the Act's implications on service delivery. This has included publishing detailed position statements and facilitating workshops aimed at integrating human rights principles into everyday practices within the sector.



Policy, Advocacy & Research

Strengthening Extended Post Care Support for Young Queenslanders

PeakCare has successfully campaigned for improvements to the Extended Post-Care Support (EPCS) program, ensuring young people transitioning from care to independence receive essential support. One key achievement was securing the application of indexation to EPCS independent living allowances, ensuring these payments keep pace with inflation and meet the evolving needs of young people.

In November 2023, PeakCare convened a key forum with EPCS service providers from across Queensland to address concerns about the services available to young people transitioning from care. These issues were raised with the Department of Child Safety, Seniors and Disability Services, resulting in the establishment of quarterly meetings between service providers and the Department.

Additionally, PeakCare has prioritised building capacity among service providers. In 2023-24, we advocated for workshops that brought together EPCS providers and partners from across Australia, creating opportunities for shared learning and collaboration. These workshops allowed providers and government representatives to work through challenges encountered in the program's rollout while celebrating successes. One of these workshops was delivered in May 2024, focusing on overcoming implementation challenges, improving accessibility, and ensuring consistent, meaningful support for young people leaving care. This collaborative approach between service providers and the Department aimed to deliver more impactful post-care support, empowering young people as they transition to adulthood.

Youth Justice Reform Submission: Advocating for Systemic Change

In February 2024, PeakCare made a significant contribution to the Youth Justice Reform Select Committee's inquiry into Queensland's youth justice systems. Our Chief Executive Officer, Tom Allsop, delivered evidence in Brisbane, and our team participated in



public hearings across regional Queensland, ensuring that the voices of frontline workers, young people, and communities were heard. PeakCare's contributions helped shape the discussion around youth justice reform, advocating for substantial, evidence-based changes.

Our submission highlighted the intersecting needs of children involved in both the child protection and youth justice systems. We advocated for early intervention services that protect children's rights and emphasised the importance of a culturally sensitive justice system informed by the lived experiences of young people and their families. Additionally, we called for research-driven reforms that prioritise the wellbeing of children and create a youth justice system that provides opportunities for them to thrive in supportive environments. Through this advocacy, we aimed to build a sustainable and responsive system that improves community safety, public confidence, and better supports all Queenslanders.

Policy, Advocacy & Research

Supporting Future Social Workers: PeakCare's Advocacy for Paid Placements

In 2023, PeakCare took a strong stance in advocating for the financial support of students undertaking lengthy, unpaid placements in fields like social work. Recognising the impact these unpaid placements have on student wellbeing and workforce diversity, PeakCare made a submission to the Australian Universities Accord.

Our advocacy didn't stop there - we also presented at the Reimagining Field Education Summit, highlighting the urgent need for support to ease the burden on students and help bridge critical workforce shortages. We were thrilled to see this advocacy come to fruition with Recommendation 14 of the Australian Universities Accord Final Report, calling for financial backing for unpaid student placements across various fields.

Recommendation 14:

That to reduce the financial hardship and placement poverty caused by mandatory unpaid placements, the Australian Government work with tertiary education providers, state and territory governments, industry, business and unions to introduce financial support for unpaid work placements.

This should include funding by governments for the nursing, care and teaching professions, and funding by employers generally (public and private) for other fields.





Chief Executive Officer Tom Allsop, PeakCare: **Community Safety Committee**

In May 2024, Tom Allsop gave evidence to Queensland Parliament's Community Safety and Legal Affairs Committee regarding the Queensland Community Safety Bill. Tom emphasised that the measures outlined in the Bill fall short of addressing the root causes of youth crime and rebuilding community trust, and that the need for innovative, communitydriven solutions that address serious repeat offending and set a visionary path for the safety of children, young people, and their communities. Tom also highlighted the limitations of Queensland's current detention system, noting that despite detaining the highest number of children in the nation, reoffending rates remain alarmingly high.

Tom urged the Committee to rethink what "last resort" truly means, advocating for a shift away from punitive measures toward more effective, long-term strategies that foster rehabilitation and community involvement.


Empowering Change: PeakCare's Advocacy 2023-2024

Throughout 2023-24, PeakCare has continued to be a driving force in advocating for policies that prioritise the wellbeing of Queensland's children, young people, and families. Over the past twelve months we developed a series of submissions that addressed crucial issues across youth justice, anti-discrimination, education, mental health, and community safety.

We stood firm in advocating for youth justice reform that prioritises rehabilitation over punishment, ensuring that the voices of young people directly affected by these policies were heard. Our submission to the draft Anti-Discrimination Bill called for a proactive and inclusive approach to eliminate discrimination and empower all Queenslanders, particularly those from vulnerable communities.

In education, we advocated for policies that safeguard the rights of all students, especially those in out-of-home care and with disabilities, ensuring they have the support needed to succeed. Our advocacy for the Queensland Mental Health and Wellbeing Strategy highlighted the need for integrated and accessible mental health services that promote resilience and wellbeing.

Recognising the complexities of knife crime, we supported legislative measures that focus on prevention and early intervention, advocating for solutions that address the root causes rather than simply imposing punitive actions. Our submission to the Putting Queensland Kids First Draft Strategy advocated for a holistic approach to children and young people's wellbeing, emphasising the importance of early intervention, community engagement, and a human-rightsbased framework. PeakCare remains committed to driving change and creating a Queensland where every child and young person has the opportunity to thrive.



Championing the Voices of Young People

PeakCare has been engaging directly with children in Queensland's youth detention centres. Children and young people are at the centre of everything we do and we are committed to providing them with a platform to share their voices on the issues that impact them the most. We didn't just listen—we amplified their stories, insights, and hopes, ensuring they were heard to help inform potential changes to government policy and legislation.



These young people, who volunteered to share their experiences, bravely allowed us to include their words in critical submissions to government. Their voices underpinned our advocacy, highlighting the importance of genuine, youth-centred policy and legislative design. Their contributions informed several key submissions, including:

- The Youth Justice Reform Select Committee, contributing to the conversation on the future of Youth Justice Reform in Queensland.
- The *Community Safety and Legal Affairs Committee*, where their words influenced discussions on the Queensland Community Safety Bill 2024.
- The *Department of Youth Justice*, shaping the draft Youth Justice Strategy with their living experiences.

We compiled these invaluable perspectives into our report, Young People's Voices, a powerful testament to the resilience and wisdom of these young people. This report has been shared back with the young people who gave their time and stories, ensuring they know their voices matter.

At PeakCare, our core belief is unwavering: children and young people are at the heart of everything we do. We're committed to working alongside our sector members to not just hear, but amplify the voices of the children and young people who navigate these systems every day. Our advocacy will continue to highlight these voices, ensuring that our recommendations to government and our messages to the public are informed by those who know the system best, young people themselves.



Sector Partnerships

In 2023-24, PeakCare worked alongside a variety of partners to develop and implement innovative solutions, enhancing the support available to children, young people, and families throughout Queensland

Supporting Innovation: Bindi Bindi Place

PeakCare is proud to have supported Communify in their successful advocacy for Bindi Bindi Place, a groundbreaking early intervention service for children from birth to age six. This program takes a proactive approach by integrating medical, early education, and mental health services into one location, all wrapped around the needs of the child. The child-focused model ensures that parental engagement is a priority, fostering positive parenting and helping children remain safely in their homes.

Bindi Bindi Place addresses the complex needs of at-risk families by providing comprehensive, coordinated support. This multidisciplinary approach strengthens family bonds and builds community capacity, offering a strong diversionary pathway away from the statutory child protection system. It also plays a key role in

reunification processes, ensuring that children can thrive in safe and nurturing environments.

With a focus on collaboration between professional services, families, and the broader community, Bindi Bindi Place is a critical initiative that lays a solid foundation for the wellbeing of both children and families.

Innovation in Action: Hackathon with YFS Ltd and IXDA

In early 2024, PeakCare collaborated with YFS Ltd and IXDA in a mini hackathon, bringing together a group of problem solvers from diverse fields to tackle the issue of improving financial literacy for young people exiting care. This group of thinkers listened and sought insight on the problem from the Extended Post Care Support team and came up with solutions ranging from the use of artificial intelligence assistants through to board games, virtual reality experiences and mentoring.

Thrive by Five Queensland: Early years advocacy support

Investing in early support for families is both economically smart and crucial for long-term success. PeakCare has been a key partner in the Thrive by Five Alliance and the Right to Learn campaign, which emphasise the need for quality early education. These initiatives focus on providing children with the foundation they need to stay in school, giving them the opportunities and support that will set them on a prosperous path in life.

The first key to keeping children safe is ensuring they have access to appropriate health checks and early education. PeakCare as a leading peak body in Queensland has called for a stronger commitment to ensuring every child can "thrive by five", including access to universal free kindy for three and four year olds.



Keeping children in schools is critical to addressing some of the root cause of crime. Department of Education acknowledge that children who are disengaged from education by the time they are seven years old, are more likely to end up in contact with the youth justice system.

The Right to Learn campaign urges that school suspensions be used only as a last resort, aligning with recommendations from the Disability Royal Commission. Although 7% of Queensland students receive a School Disciplinary Absence (SDA), the most vulnerable are disproportionately affected: 15% are First Nations, 15% have disabilities, and nearly 25% come from out-of-home care. This highlights how vulnerable students are more likely to be excluded from education despite relatively low overall numbers.

In May 2024, PeakCare participated in the Minister for Education's Roundtable on school behaviour, which focused on addressing SDAs. Representing our sector and advocating for children and young people in out-of-home care, we emphasised the importance of keeping children in school, fostering their engagement in learning, and ensuring schools remain safe and supportive environments for education.

Strong partnerships with the non-government sector are critical in reversing these trends. As the peak body for child and family services, PeakCare is committed to keeping children in school, ensuring they remain engaged in learning and feel safe. This approach is central to reducing future youth offending rates, particularly for children with disabilities, First Nations children, and children-in-care.


Safe & Sound in Queensland: Keeping Kids Safe and Supported

In response to the rising concerns around missing children in care, PeakCare partnered with Queensland Family and Child Commission (QFCC) and Project Paradigm to create the Safe & Sound in Queensland Toolkit — a resource designed to give both young people in care and service providers the tools they need to navigate these challenging situations with confidence and care.

Safe & Sound offers practical, professional support for children who go missing from their home or place of care, with strategies and step-by-step guidance to help care workers. The resource is designed to support children and young people to feel heard and to help reshape their experiences before, during, and after an episode of going missing.

The toolkit brings together the latest best practices, informed by real input from children, youth workers, law enforcement, and child protection professionals. It's designed to compliment and enhance the work agencies are already doing, ensuring that every missing child gets the safest, most compassionate response possible. With this toolkit in hand, we're ensuring that when a child goes missing from care in Queensland, the response is consistent, thoughtful, and aligned with international best practices.

We're incredibly proud of this collaboration with QFCC and Project Paradigm, and we're excited to see it make a real difference in the lives of Queensland's children.





Building Tomorrow's Workforce: PeakCare's Talent Centres

At the heart of our sector are the incredible workers who show up every day for children, young people, and families, and thanks to PeakCare Talent Centres, we're growing that workforce even further.

Through partnerships with Workforce Connect and Look Now Training, the program combines expert-led training with work placements, career planning, and employer networking. Whether delivered face-to-face or virtually, PeakCare Talent Centres ensure accessibility and provide participants with a direct pathway to employment in this rewarding field.

This vital initiative, proudly funded by the Queensland Government through the Workforce Connect Fund, is helping to shape the next generation of workers in child and family services.

Exploring Global Approaches to Youth Wellbeing: PeakCare's Conversation with This Life Cambodia

In June 2024, PeakCare partnered with This Life Cambodia to host a discussion on international approaches to enhancing wellbeing and ensuring safety and justice for young people, their families, and communities.

This Life Cambodia has achieved remarkable reductions in recidivism rates - from 60% to less than 2% - through approaches rooted in community engagement, participation, and empowerment, leading to transformative outcomes for imprisoned young people.

This was an inspiring session featuring insights from Margaret Allison AM and Billy Gorter, Executive Director of This Life Cambodia, offering valuable lessons for how we might rethink and strengthen youth justice and family support systems here

in Queensland.



Reforming Foster Care: New Report Unveils Critical Shortages

In June 2024, PeakCare, in partnership with the Queensland Family and Child Commission (QFCC) and The Demographics Group, released the Queensland Foster Carer Demographic Insights Report - a comprehensive analysis revealing the challenges facing Queensland's foster care system. This report is the first of its kind in Queensland and provides a critical evidence-base for addressing the significant strain on foster care.

The report reveals a concerning trend: the pool of available foster carers is shrinking despite the overall population growth in Queensland. Rising living costs, changes in household composition, and evolving social norms are key factors contributing to this decline. Fewer families have spare bedrooms, and financial pressures are making it increasingly difficult for individuals and families to commit to the role of foster carers.


Until recently, Queensland foster carer numbers have remained relatively stable, but latest Australian Institute of Health and Welfare (AIHW) data shows a decline, compounded by residential care placement numbers which have more than doubled in the last five years – higher than any other jurisdiction in Australia. This is especially concerning for First Nations children who continue to be significantly over-represented in the child protection system.



The report provides generational insights and explores some of the traditional foster carer personas, helping to understand the unique challenges and opportunities for agencies striving to recruit and retain carers.

Highlighting the need for systemic reform, the report calls for greater financial and logistical support for foster carers and agencies, and innovative models of foster care. It also emphasises the state's need for an improved approach to recruitment and retention recognising the critical role foster carers play in child protection.

The Queensland Foster Carer Demographic Insights Report represents a significant step forward in tackling some of the issues facing the care system. By leveraging these insights and implementing the recommended strategies, Queensland can develop a more resilient and effective foster care workforce that meets the needs of children, young people, families and carers across the state.



Driving Change with Data: Evidence-Based Decision Making Masterclass

In October 2023, PeakCare, in collaboration with OzChild and the Center for Evidence-Based Management, hosted a masterclass on Evidence-Based Decision Making in Brisbane. The event was attended by 35 sector leaders, including CEOs and practitioners and has equipped sector leaders with the tools to make informed, data-driven decisions that will enhance service delivery across Queensland.

Feedback was overwhelmingly positive, with **90%** of participants rating their overall satisfaction as very good or excellent.



Hope & Healing Masterclass: Positive Behaviour Support & Managing High-Risk Behaviours

Hope & Healing continued to grow in 2023-24 with over **30,483** registered users as of 30 June 2024. This program remains a major element of our capacity-building efforts, providing mandated training to carers and workers across the state. In partnership with the Department of Child Safety, Seniors and Disability Services, PeakCare introduced the Positive Behaviour Support & Managing High-Risk Behaviours Masterclass, an advanced training opportunity for graduates of the mandatory Hope & Healing - Residential Care training in January 2024. As at 30 June 2024, we had **614** completions of this offering.

This Masterclass was designed to provide residential care workers and supervisors with a deeper understanding of Positive Behaviour Support practices and the Department's Managing High-Risk Behaviours policies.

The training builds on the foundational Hope and Healing course by enhancing trauma-informed care practices for young people with complex behavioural needs. The course covers key topics such as trauma-informed care, understanding prohibited and restrictive practices, and effective strategies for managing high-risk behaviours.

Masterclass modules have so far received an average satisfaction rating of **4.6 out of 5**, highlighting our commitment to continuous professional development and capacity uplift for the sector.

Recognising the Importance of Kinship Care: A National Call for Support and Action

Kinship carers play a crucial role in protecting and supporting children across all jurisdictions. While many believe kinship carers are mostly grandparents, the latest Census data reveals a broader reality—nearly half of all kinship carers are other relatives or close family friends. Over 80% of these carers provide informal care, receiving little to no recognition or financial support from child welfare systems.

In June 2024, PeakCare, in partnership with Kinship Alliance Australia, was honoured to host a special in-person event featuring Kate Bundle, former Chief Executive Officer of the NZ Grandparents Raising Grandchildren Trust. The event focused on achieving national recognition and support for all kinship care families.

We were delighted to have Meredith Kiraly, Honorary Fellow at the University of Melbourne, and Mike Feszczak, Chief Executive Officer of Grandcarers SA, join us to introduce Kinship Alliance Australia. This alliance holds regular meetings with the Federal Parliamentary Friends of Grandparent and Kinship Carers, advancing important discussions and advocacy for kinship care. This highly anticipated event reached full capacity, sparking a meaningful conversation about the future of kinship care and we are proud to announce that PeakCare has since joined Kinship Alliance Australia. We will continue to update our members as we advocate for stronger support for kinship carers at the federal level.



Changing the Balance: Strengthening First Nations Child & Family Support

All states and territories have committed to the Australian Government's Safe and Supported Framework for Protecting Children, a critical action plan aimed at shifting investment in child and family services for Aboriginal and Torres Strait Islander communities. This plan focuses on increasing the proportion of funding directed to Aboriginal and Torres Strait Islander Community Controlled Organisations (ACCOs) to better serve these communities.

In May 2023 PeakCare CEO, Tom Allsop, joined the Families Australia Board of Directors. Families Australia, the national peak body for children and families, was tasked in early 2024 with leading a research project called Changing the Balance, exploring the impact of this funding shift on mainstream nongovernment organisations. This project complements a broader initiative led by SNAICC, which aims to strengthen the capacity of ACCOs.



As part of this work, Families Australia was responsible for facilitating sector consultations across Australia. In April 2024, PeakCare proudly partnered to deliver these consultations in Brisbane and regional Queensland. These sessions were well-supported by PeakCare members and provided a platform for collaborative discussions on the impacts of funding realignment, building capacity, and ensuring all children, young people, families, and communities in Queensland receive the support they need.



Beyond a Checklist: Shaping the Future of Queensland's Residential Care System

Throughout 2023, PeakCare travelled across Queensland to engage directly with frontline workers, service organisations, carers, parents, and, most importantly, young people. These conversations were central to our report, Beyond a Checklist: Guiding the Road Forward for Queensland's Residential Care System, which consolidates the voices and expertise of the sector to shape a better future for residential care.

Beyond a Checklist amplifies these voices and offers clear opportunities for improvement, especially around recruitment, retention, and the wellbeing of residential care workers, carers, and children alike.

The report highlights both the strengths and challenges within the system, making clear that the future of residential care must focus on connection, consistency, and trust. PeakCare is incredibly grateful for the individuals and organisations willing to share their experiences and ideas throughout the review process and we acknowledge these voices are vital in shaping a system that is more responsive, sustainable, and centred on the needs of the children and families it serves.

From forums across the state to in-depth conversations during residential care home visits, we heard stories of dedication, struggle, and hope. These insights are not just valuable—they are essential to creating a care system that works for everyone

involved.

report calls for This urgent reforms, including innovative approaches to foster carer recruitment. workforce support, and service delivery models. We believe that with the right plan in place, Oueensland's residential care system can move beyond stop-gap measures and towards sustainable. long-term solutions that put children's needs first.



The Road Ahead: Release of the Residential Care Roadmap

In February 2024, the Queensland Government's Residential Care Roadmap was released, resulting from the Government's review into the residential care system. PeakCare played a pivotal role in shaping the Roadmap, which outlines 31 essential actions needed to improve outcomes for young Queenslanders, representing a significant step forward in our collective effort to enhance Queensland's residential care system.

PeakCare remains committed to advocating for the reforms outlined in Beyond a Checklist. We are hopeful that Queensland's Residential Care Roadmap will set the foundation for a new, aspirational path, one that integrates disconnected service systems and puts relationships, trust, and respect at the heart of our non-family-based care system.

Key focus areas for this roadmap include halving the number of children and young people living in residential care, increasing the number of children and young people cared for by kin and foster carers, improving culturally led and intervention support, and reducing the disproportionate representation of Aboriginal and Torres Strait Islander children and young people in care. The release of the Roadmap for Residential Care in Queensland does not mark the end of this important process. It instead opens a new chapter for residential care in Queensland. A chapter where success is not measured by the number of actions proposed, but by how these actions are delivered on to create the best possible system for the smallest number of children who need it most.





Catalyst for Care


In 2023-24, PeakCare looks ahead to the establishment of the Catalyst for Care Program, a new initiative designed to address opportunities to best support the residential care sector workforce

Catalyst for Care is a program commissioned by the Queensland Government to improve outcomes for young people in residential care by addressing current and emerging workforce challenges.

To do so, the Program will deliver:


- 1. A **residential care workforce strategy**, to meet the current and future workforce needs of the sector
- 2. An expansion of Queensland's **Hope and Healing Framework** and related training to equip the workforce with a broader range of essential knowledge
- 3. A new **sector-led forum** to showcase and recognise best practice across the sector

Our phases of work



In line with our commitment to sector engagement, we will over the next 12 months conduct extensive consultations to gather direct feedback from every region of Queensland on what employers and employees need to create a sustainable and stable residential care workforce.

These consultations will inform the development of a comprehensive workforce strategy and guide the modernisation of the Hope & Healing Framework. The program will also plan Queensland's first-of-its-kind event celebrating and affirming excellence in residential care.

In 2023-24, PeakCare undertook a major brand refresh to modernise our brand design, logo, and accommodations to enable us to better support the needs of our Members, the sector, and children and young people

For over four decades your child and family peak body has celebrated and advocated for children, young people and families in Queensland, continually evolving our vision, purpose and identity to meet the needs of the changing child welfare landscape. 
Brand refresh


