Introduction to the PeakCare Board Candidate Pack

Welcome to the Candidate Pack for PeakCare Queensland's 2024 Board Elections. This document introduces you to the nominated candidates for positions on the PeakCare Board, providing their nomination statements to help you make an informed decision during the voting process.

The election is conducted in accordance with the rules outlined in PeakCare's Constitution. These rules ensure a fair and transparent process, enabling all Member organisations to have a voice in selecting Board members who will uphold PeakCare's vision and values. Voting will take place via a secure online voting system, ensuring accessibility and ease for all participants, shortly prior to the AGM.

Key information to assist you in the voting process includes:

Election Rules

The election process adheres to the stipulations outlined in PeakCare's Constitution. All nominations have been reviewed to confirm eligibility. Voting will occur through a secure online voting platform, ensuring confidentiality and the accurate recording of each Member organisation's vote. Vote outcomes will be announced at PeakCare's AGM on Friday 29 November 2024.

Changing the Authorised Representative of a Member Organisation

Each Member organisation has the right to nominate a representative to cast their vote. If a change is required, the organisation must notify PeakCare of the new authorised representative prior to the voting period.

Please submit the updated representative details in writing to PeakCare's office by the specified deadline to ensure they are registered as the voting delegate. Ballots will be issued in two weeks' time and therefore request any changes to authorised person or proxies be provided by 20th November 2024. Requests after this date may cause delay in access to the ballot system.



Proxy Voting Guidelines


Member organisations unable to have their authorised representative vote directly may nominate a proxy to vote on their behalf. Proxy nominations must be lodged using the designated format and submitted to PeakCare by the stated deadline. This ensures all Member organisations maintain their opportunity to participate in the election, even if their representative cannot vote personally.

Online Voting Instructions

Comprehensive instructions for using the online voting system will soon be provided to the authorised representatives of Member organisations (or their proxies). These instructions will outline the steps for accessing and casting your vote securely, as well as key dates and deadlines for the voting period.

I have focused on raising awareness around the declining number of foster carers and the increasing demands on carers and agencies alike.

I'm also a huge advocate for early intervention and prevention, and the continued investment into family preservation and early intervention across the sector with significantly more investment for our ACCO colleagues.

It has been a privilege to contribute to the sector's growth and evolution, and I am committed to raising awareness of the challenges we face and celebrate the work of our diverse sector in supporting children and families in need.

Current Employment Details:

Founding and Executive Director/CEO Little Stars Foundation

I founded Little Stars Foundation (previously Little Stars Kids) in November 2014. Our inaugural program, Little Stars Kids Camps, started in 2016. Little Stars Kids Camps provided day camps for children aged 4-12 living in foster, kinship and residential care. At its peak in 2020 we serviced over 120 children who were regular campers, attending at least 4 day camps per year. These children were supported by over 130 volunteers who were one- on-one consistent camp buddies and volunteers with varied experience including teachers and psychologists. The camp program was supported by Act for Kids, and we collaborated with various foster agencies who referred children to the program. Largely, the program grew by word of mouth. The camp program was funded entirely through philanthropic efforts and volunteers. In 2019/2020, the camp program was unable to continue due to covid. In 2022, the Little Stars Learners program commenced and was adopted by various foster agencies including Mercy Community services, Kyabra, Infinity Community Solutions and Key Assets and offers made to contribute to funding more children in the program. The Foundation continued to subsidise children's costs and continued to provide full scholarships for participation in the Little Stars Learners Program. The Little Stars Learners program provides trauma informed, flexible in-home learning support for children living in foster, kinship and residential care in Southeast Queensland. As executive director, I am responsible for overseeing the strategy and high level development of the program and the overall financial position of the organisation. I am responsible for reporting to the Board on all financial and strategic matters.

RELEVANT EXPERIENCE

Abused Child Trust (now Act for Kids) research committee

In addition to my experience with Little Stars Foundation, I was a member of the previous Abused Child Trust Research Committee when I was a partner at Clarkekann lawyers. I was asked to be involved in this by a fellow partner, Bill Blake, who was also a member. This committee was responsible for commissioning research with limited funds on matters relating to child abuse and neglect. During my time, the Research committee commissioned research on the impacts of shaken baby syndrome and also research by Ben Mathews on the Criminal Justice System – Issues concerning Child Abuse.

My past experience key highlights includes the following:



Lawyer - Slater and Gordon Lawyers (Victoria)

I started my legal career as a lawyer for Slater and Gordon in Victoria in 1995. I was working a regional community and as a result had a significant amount of experience in advocating for individuals including representing employees independently in the industrial relations commission in relation to terminations of employment and also representing individuals in equal opportunity and discrimination claims. This role involved working with a law firm who was very strong on advocacy for the underdog and those who were vulnerable and could not defend themselves. Through this role I gained significant experience in litigation and also in the mindset of accepting that a David/Goliath situation was nothing to fear.

Lawyer- Freehills (Queensland)

In 1999 I moved to Queensland and took up a role in the Brisbane office of Freehills working in employment law and also commercial litigation. During this role I honed my skills in writing complex advices and putting together and presenting training modules for senior executives on various matters related to equal opportunity law and employment law. I was also involved in a complex class action involving failed female sterilisation devices amongst other high profile litigation which involved extensive collaboration with various stakeholders both within and outside the office.

Clarkekann Lawyers- Head of Department/ Partner role

In 2006 I was promoted from Senior Associate to Partner at Clarkekann lawyers and headed up the employment and industrial relations practice. This came about as a result of my ability to grow the client base and fees income of the employment practice from zero to what became a profitable legal practice unit. As part of my time at Clarkekann I developed a training arm of the practice called CK workwise training through which I developed and provided (along with junior staff members) comprehensive workplace relations and industrial relations training to workplaces including senior managers on topics including risk management, workplace health and safety, dealing with workplace incidents and investigations, equal opportunity training and training on new IR Laws.

Honeychurch Workplace Lawyers - Business Owner and Principal Legal Practitioner and

In 2009 I left Clarkekann to commence my own employment, industrial relations and litigation practise and managed the practise until 2015 when my mother passed, and I moved to an in-house role with Keema Automotive Group which is our family business. At Keema Automotive Group I was responsible for providing advice to senior executives and the management team and putting in place training/systems/policies and procedures to reduce risk and maximise productivity. I remained in this role until May 2019.

Legal Case- Pro bono for Foster Carers

During 2013 I became involved in supporting a foster carer in proceedings in the family court seeking long term parenting orders for a child who was in their care. This case is a precedent case where final permanent care orders were granted to foster carers in circumstances where it was ultimately found that the child was at risk of serious harm as a result of a reunification with a biological parent and that policies and procedures had not been followed in that reunification.

My name is Carly Jacobitz. Please accept this candidate statement by way of nomination for the vacant *PeakCare* Board positions. I have had the privilege of serving on the *PeakCare* Board for the past three years and am currently Deputy Chief Executive (Child, Youth and Family) at Life Without Barriers.

I have 18 years operational and executive experience across both government and non-government organisations specialising in child protection at both an individual and system level. I have a unique perspective derived from experience in front line statutory child protection and now nationally with one of Australia's largest out of home care providers, Life Without Barriers. I have undergraduate and postgraduate qualifications in psychology and business and am a registered psychologist with a deep interest in trauma informed and evidence-based practice. I am also a graduate of the Australian Institute of Company Directors.

Non-government organisation's engagement with children, young people and their families facilitates the exchange of critical information used to determine safety and wellbeing. Consequently, the participation of non-government organisations in sector advocacy and decision making is paramount. The intersection of core challenges that exist within child and family, including domestic and family violence (DFV), drug and alcohol use and parental mental health, require effective solutions at a system level, involving a broad array of stakeholders.

A system and sector wide commitment is also necessary to listen to, and engage, Aboriginal and Torres Strait Islander children, young people, their families and communities to address over-representation within both the child protection and youth justice systems. I hold a strong value alignment to self-determination for Aboriginal and Torres Strait Islander individuals, families and communities. Well-developed stakeholder management has been critical to my success as an executive leader. I have broad networks and regularly act as a conduit between sector and government. I currently serve on the Board of *DVConnect* and have experience on government Boards including my current appointment by QLD's Attorney General to the *Queensland Child Death Review Board*.

I am a strong advocate for diversity and inclusion, and believe the best solutions are crafted, and the best decisions made, when differing views are presented. The solutions to social challenges facing today's communities require transparency and commitment from industry and government. Sustainable solutions are best found when the sector wrestles with complex questions, leans into difficult conversations and are bold in their ask of partners. Having spent the largest part of my career in government or the not-for-profit sector, I have a strong commitment to delivering outcomes to vulnerable children, young people, and families.

I am excited about the opportunity to continue with the Board of *PeakCare* and seek your support to do so.

A recent recipient of QLD Child Protection Week Regional Program Award of Jayur House, SCSS is QLDs largest licenced provider of residential care services. We currently provide CYF services across every region of QLD. Additionally, SCSS are proud to provide services nationally under NDIS.

SCSS, a proud PeakCare member, is committed to delivering holistic support to children, young people, and families, ensuring quality care across geographically dispersed regions.

Governance Experience and Skills

With over 20 years of experience in the child protection and family services sector across Victoria, QLD, NSW and Tasmania. I posessess a strong background in frontline roles including Forensic Counsellor in a correctional centre, Youth AOD support worker, senior practitioner, and team leader across specialist youth homelessness services. I am a strong advocate of supporting resilience and self determination for anyone facing challenges. I am exceptionally passionate around family preservation and reunification.

I bring a wealth of knowledge in strategic planning, compliance, and operational leadership. I am an active member of the Strategic Reference Group for the National Therapeutic Residential Care Alliance (NTRCA) and participate in PeakCare's Catalyst for Care Reference Group. Further SCSS participate on the Reporting for Outcomes Governance Group being triallied in the Brisbane Moreton Region by the Department of Child Safety, Seniors and Disability Services.

My previous board roles include serving as a Director for Variety Children's Charity and as a Board Director with the Peakbody for Families and Children in Tasmania (FACT). I am also a regular volunteer in the homelessness sector in the Moreton Bay Region.
